- A. A completed and signed application from <u>all</u> proposed occupants over the age of 18 must be submitted. *ALL LINES MUST BE FILLED IN*. Incorrect or misinformation will disqualify you as a prospective renter.
- B. An application fee of **\$30.00** per applicant will be required upon submission of this application for the cost of processing, obtain credit history, eviction reports, and other background information.
- C. You must provide photo I.D. We require a photo I.D. (Driver's license, State Issued ID card, or *Military card*.)
- D. We will obtain a credit report for <u>each</u> applicant and co-signer (18 years of age or older). Reports supplied by applicant(s) <u>will not</u> be accepted. You must have a credit report that demonstrates a willingness to pay financial obligations in a timely fashion and/or have a FICO score of at least 620.
- E. You must have no records of eviction.
- F. We require favorable responses from references and previous landlords.
- G. Employment History and Sufficient Income: We require your current monthly debt obligations and new rent not be more than 40% of your gross monthly income (income before taxes) per applicant. Income must be verifiable through pay stubs, employer contact, or tax records. All other income, including self employment must be verified through tax records.
- H. Rental History must be verifiable from unbiased sources. If you're related by blood or marriage to one of the previous landlords listed, or your rental history does not include at least two previous landlords, your application may be declined, or we may require a qualified co-signer on your rental agreement. Qualified co-signers must meet all screening criteria plus make 3 times the amount of rent.
